Purposes and legal bases of the data processing, according to Art 13 para. (1) lit. c) DSGVO

The personal data will be processed for the purpose of the performance of contracts or for the implementation of pre-contractual measures. This includes the customer master data with contact persons as well as the contact history, offers, orders, invoices, project data and other legal obligations of the responsible person.

The personal applicant data will be used for the justification of the employment relationship. The legal basis is Art. 6 DSGVO. Further essential legal bases arise from the German Commercial Code, tax law, GMBH law and other legal requirements relevant to the H2O limited liability company. These also include contractual regulations. The processing of newsletters is based on the consent of those involved. The legal basis for applicants arises from Art. 6 DSGVO and §26 BDSG new (data processing for employment purposes). This also includes contractual provisions and internal company guidelines / regulations of the H2O limited liability company. Consent for further data processing after completing the application process and conducting an employment test.

Processing is for the protection of the legitimate interests of the person in charge or a third party according to Art 13 para. (1) lit. d) DSGVO

If necessary, we process your data beyond the actual fulfilment of the contract for the protection of legitimate interests of us or third parties. This includes:

- Sales management and sales controlling

- Asserting legal claims and defence in legal disputes
- Applicant management
- Ensuring IT security and IT operations
- Measures for building and plant safety (e.g. access control) and for the maintenance of the domiciliary right
- Measures for business management and development

Categories of recipients of personal data (data transmission) according to Art 13 para. (1) lit. e) DSGVO

Within Germany, the European Union and the European Economic Area

Germany:

Auditors, bailiffs and other creditors as well as other public authorities for fulfilling legal obligations and for requested certificates, logistics companies, customers as well as suppliers and other agencies and business partners.

Third country incl. adequacy decision according to Art 13 para. (1) lit. f DSGVO

In the context of international business relations, the transmission takes place according to Article 6 (1) (b) for the performance of contracts or the execution of pre-contractual measures. No adequacy decision is needed here.

Storage duration according to Art. 13 par (2) lit a)

The respective purposes result from legal requirements as well as from relevant branch-specific regulations. The personal data will be deleted after fulfilling the purpose.

Rights of data subjects according to Art. 13 par (2) lit b)

You can exercise your rights at any time by using the above contact information. If your personal data is processed, you are a data subject within the meaning of the DSGVO and you have the following rights towards the person responsible:

Information about the rights of data subjects

The data subject has the right to ask the person responsible for information about whether personal data is processed; if this is the case, he has a right to information about this personal data and to the information listed in Article 15 of the DSGVO.

The data subject has the right to demand the correction of incorrect personal data concerning him / her and, if necessary, the completion of incomplete personal data from the person responsible without delay (Art. 16 DSGVO). The data subject has the right to demand that the person responsible would delete personal data relating to him / her be without delay, provided that one of the reasons detailed in Art. 17 GDPR is fulfilled, for example, if the data is no longer needed for the purposes pursued (right to deletion).

The data subject has the right to demand that the person responsible restricts the processing if one of the conditions listed in Art. 18 DSGVO is fulfilled, for example, if the data subject has objected to processing for the duration of the review by the controller.

The data subject has the right, at any time, to object to personal data concerning him / her for reasons arising out of their particular situation. The controller then no longer processes the personal data unless he can demonstrate compelling legitimate grounds for processing that outweigh the interests, rights and freedoms of the data subject, or the processing serves the assertion, exercise or defence of legal claims (Art 21 DSGVO).

Rights of data subjects according to Art. 13 par (2) lit. c) DSGVO

Insofar as you have given us consent to the processing of personal data for specific purposes (e.g. processing of images of the data subjects), the legality of this processing is based on your consent.

A given consent can be revoked at any time. This also applies to the revocation of declarations of consent that were issued to us before the validity of the DSGVO, i.e. before May 25, 2018.

Please note that the revocation is only effective for the future. Processing that occurred before the revocation is not affected.

Complaint right with a supervisory authority acc. to Art 13 para. (2) lit. d) DSGVO

Without prejudice to any other administrative or judicial remedy, any data subject shall have the right to file a complaint with a supervisory authority if the data subject considers that the processing of personal data concerning him / her violates the DSGVO (Article 77 DSGVO). The data subject may assert this right with a supervisory authority in the member state of his or her residence, place of work or place of alleged infringement.

Data collection on our website

Who is responsible for the data collection on this website?

Data protection

Information, blocking, deletion

Google Analytics

Order data processing

We have entered into a contract data processing agreement with Google and fully implement the strict requirements of the German data protection authorities when using Google Analytics.

Demographics in Google Analytics

Google AdWords and Google Conversion-Tracking

7. Plugins and Tools

Google Web Fonts
